



## 2017 MVCA HOME & GARDEN EXPO JURIED CRAFT SHOW ELIGIBILITY AND GUIDELINES

### ELIGIBILITY

1. Handmade and unique items sought. No garage sale or resale merchandise.
2. All exhibits and merchandise must be suitable for family viewing. No offensive items permitted.
3. Accepted vendors will be notified by committee.

### THE EVENT

1. Show hours: Saturday and Sunday, March 25-26, 2017 at Riverview Mall. Prior to setting up, vendors will receive space assignment from Rick at event site.
2. Set-up is Friday, March 24, 1-7 p.m. and Saturday, March 25, from 8-9 a.m. (minor set up).
3. Breakdown will begin at 3 p.m. on Sunday. (Please see item 9 below.)
4. Security will be provided.

### APPLICATION

1. Vendors must submit three (3) photos of vendor products and one (1) photo of vendor booth must be attached to application. (Photos in jpg format not to exceed 100kb may be emailed to: [aswanson@tri-state-ace.com](mailto:aswanson@tri-state-ace.com). Please include MVCA Craft Show in subject line.
2. Include category and description of items to be sold.
3. Payment must be made by check and accompany application.
4. Include copy of Arizona Sales Tax Permit.
5. Include copy of Arizona Business License.
6. Send application and make check payable to:

7. Space is assigned in order of receipt of application and payment.
8. Craft vendor rate is \$100 for a 10' x 10' space. A 10' x 10' space with electricity is \$125. One (1) 6' table and two (2) chairs will be provided. **Reserve and pay before February 15 and earn a \$25 Early Bird discount.**
9. A deposit of \$50/space will be made with application. This deposit will ensure you leave your area undamaged and clean. No early break down is allowed. You will forfeit your deposit if you break down or leave the show early on Sunday and will not be allowed to participate in the 2018 MVCA Home and Garden Expo Juried Craft Show.
